BY-LAW NUMBER 21-2007

BEING a By-law to rescind By-law No. **15-2002**

BEING a By-Law to accept "Waste" in the Municipal Waste Disposal Sites.

WHEREAS pursuant to Section 209A S.S. 2, of the Municipal Act, R.S.O. 1980, by-laws may be passed to assume any or all of waste management powers.

AND WHEREAS the Council of the Municipality of Machin has deemed it appropriate to accept waste as defined under Section 209A S. S. (1) of the Municipal Act R.S.O. 1980.

NOW THEREFORE the Council of the Municipality of Machin ENACTS AS

FOLLOWS:

1. Definitions:

In this by-law:

- (a) "Waste" means ashes, garbage, refuse, domestic waste, industrial solid waste or municipal refuse and such other wastes as may be designated by by-law passed by the Council.
- (b) "Waste Management Power" means any power conferred by any general or special Act on local municipalities or local boards thereof related to the collection, removal, disposal, treatment, storage, processing, transfer, reduction, reuse, recovery or recycling of waste.
- (c) "Unincorporated Areas" means Mutrie Township, East Aubrey Township, Wabigoon Township, Redvers Township, Colenso Township, Smellie Township, East end of Canyon Lake in the Unorganized area North of Smellie Township, Docker Township, Buller Township and Eton Township.
- (d) "Municipal" means Langton Township, Sanford Township, West Aubrey Township and Temple Township.
- (e) All household and paper garbage brought to the landfills must be bagged or boxed; newspapers and cardboard may be recycled providing recycling rules are followed.
- (f) All denoted sites for metal, brush, shingles, batteries, tires and raw wood must contain only those material (as directed by the landfill attendant). Anyone disregarding the attendant's directions will be fined.
- (g) Recyclables, raw wood and brush dumping is free of charge.
- (h) Items labeled "Dangerous Goods" are not to be disposed of in the municipal landfill sites.
- (i) Sharps (needles) must be safely containerized prior to dumping in the municipal landfill sites.
- (j) Municipal landfill sites are not bear-watching sites for public use. They are considered No Trespassing sites when gates are locked.

- (k) Any garbage left outside the landfill site gates will be checked for identification and an invoice will be sent to the "owner" at double the normal rate of dumping plus an hourly rate for the time spent by staff to clean it up.
- (l) Anyone caught violating this By-law may have their dumping privileges revoked.

This by-law shall come into force and take effect upon the final reading hereof.

READ a FIRST, SECOND and THIRD time and Finally PASSED this 25th day of June, 2007.
