8.1 Public Works Verbal Report – August 2022

Gave a verbal report on the work that the crew has been doing. Put recycled pavement on Townline Road around the corner, would like to get 2 more loads on the other side of the corner and at the stop sign. Next spring would like to hire another full-time person for public works grass crew to replace the two part-time people. Ojibway Drive is completed. Will leave any money left in this years budget for calcium for next year. Roads are being graded.

The shop door was adjusted and opens a little better but should be replaced.

The crew are building new road barricades.

Had issues with the filters in August but are working better now. The chemical pumps will need to be replaced, the plant will need to be shut down for 4 hours while this is being done. This will be done in the next couple of weeks.

The water on Armstrong and Pine is being monitored for chlorine, none has been found, therefore it is believed to be surface water or a spring.

The graffiti at the water plant low lift building has been cleaned off. New surveillance cameras will be put in next years budget.

New smoke detectors will also need to be replaced.

8.3 Woodland Arena Verbal Report – August 2022

The Committee would like more information on bookings before a decision is made on when the ice will be put in, so far there is one booking in November. The new online booking system will be ready to go on the website as soon as the new Eagle River Hall rental agreement is approved by Council tonight.

Minor hockey will book ice as long as they have kids that join, and the Eagle Lake Figure Skating club will book once a week. Carman has been contacting the different leagues/clubs about booking ice times.

The Committee would like to try to keep ice time bookings on the same days, and not to open the arena to public skating if there are no rentals.
